ARA RE Investment Group (Singapore) Pte. Ltd. ("ARA RIGS") holds 100% of the shares of ARA RE Investment Group Limited ("ARA RIG"), which in turn holds 100% of the shares of ARA Investors II Limited ("ARA Investors II"), ARA Real Estate Investors XII Limited ("ARA RE XII") and ARA Real Estate Investors XIII Limited ("ARA RE XIII").

Accordingly, ARA RIGS and ARA RIG are therefore deemed to be interested in the units in Suntec REIT held by each of ARA Investors II, ARA RE XII, ARA RE XIII.
