On 28 February 2023, ARA Investors II Limited, ARA Real Estate Investors XII Limited and ARA Real Estate Investors XIII Limited (collectively the "AREI subsidiaries") have collectively transferred 188,141,706 units of Suntec Real Estate Investment Trust ("Suntec REIT Units") to ARA Real Estate Investors 22 Pte. Ltd. as part of an internal restructuring.

ARA RE Investment Group Limited holds 100% of the shares of each of the AREI subsidiaries. Accordingly ARA RE Investment Group Limited is therefore deemed to be interested in the Suntec REIT units held by each of the AREI subsidiaries.
